Administrative Procedures Act

SB-1235 (Caballero) - Administrative Procedure Act: adverse economic impact.

The bill would have deleted the requirement that a state agency prepare an economic impact assessment for proposed changes to a major regulation proposed prior to November 1, 2013, and would have instead required a state agency to prepare a standardized regulatory impact analysis for proposed changes to all major regulations. Additionally, the bill would have required that state agencies to conspicuously post the regulatory impact assessment on its internet website within 24 hours of submitting the reports to the Department of Finance.

Alcoholic Beverages

SB-21 (Dodd) - Alcoholic beverages: brewpub-restaurant licenses.

This bill lowered the required minimum brewing production of a brewpub-restaurant licensee from 200 barrels per year to 100 barrels per year.

SB-58 (Wiener) - Alcoholic beverages: hours of sale.

This bill would have authorized the Department of Alcoholic Beverage Control (ABC) to create a pilot program, beginning January 1, 2022, and before January 2, 2027, to issue an additional hours license to an on-sale licensee in a qualified city (Cathedral City, Coachella, Fresno, Long Beach, Los Angeles, Oakland, Palm Springs, Sacramento, San Francisco, and West Hollywood) that would have allowed the selling, giving, or purchasing of alcoholic beverages at the licensed premises between the hours of 2 a.m. and 3 a.m., upon completion of specified requirements.

SB-264 (Glazer) - Wine growers: tasting rooms.

This bill would have authorized a licensed winegrower or brandy manufacturer to operate two off-site tasting rooms under its winegrower license.

SB-352 (Dodd) - Alcoholic beverage licensees: on-sale general licenses for bona fide eating places.

This bill would have authorized the Department of ABC, in counties that have reached its limit of on-sale general licenses, to issue up to 10 additional new original on-sale general licenses for bona fide eating places following the year the limit is reached.

SB-420 (Archuleta) - Alcoholic beverage licensees: beer and wine importers, beer and wine importers general, and beer and wine wholesalers.

This bill would have removed the beer and wine importer license, the beer and wine importer's general license, and the beer and wine wholesaler license and replaced them with a separate beer or wine license, as specified, and makes relating changes within the ABC Act with regard to the privileges and restrictions of these licenses.

SB-432 (Nielsen) - Alcoholic beverages: distilled spirits: instruction.

This bill authorized a distilled spirits wholesaler, rectifier, brandy manufacturer, or craft distiller to furnish distilled spirits and the equipment, materials, and utensils that may be required for use in connection with the instruction or courses of instruction. Additionally, this bill authorized rectifiers and brandy manufacturers to instruct licensees and their employees, on the subject of distilled spirits, as specified.

SB-717 (Jones) - Advertising:

This bill authorized a craft distiller to purchase advertising space from, or on behalf of, an on-sale retail licensee subject to the same conditions as other alcohol manufacturers.

SB-788 (Committee on Governmental Organization) - Alcoholic beverages: appeals: decision: tied-house restrictions.

This bill clarified, for purposes of the ABC Act, that an emergency order issued by the Department of ABC is not a "final decision." The bill also provides that a superior court shall have jurisdiction to review an emergency decision issued by the Department of ABC.

SB-866 (Dodd) - Alcoholic beverages: on-sale licenses: County of Napa.

This bill would have authorized the Department of ABC to issue up to 10 additional new original on-sale general licenses per year in Napa County for a period of five years.

Status: Never heard in the Senate Governmental Organization Committee

SB-918 (Committee on Governmental Organization) - Alcoholic beverages: special nonprofit sales license: wine labels.

This bill clarifies a current provision in law that allows the Department of ABC the authority to issue a special nonprofit sales license to the University of California, Davis (UC Davis), as specified; and requires any wine bottled on or after January 1, 2023, and labeled with an American Viticultural Area (AVA) that is located entirely within the County of Mendocino to bear the designation "Mendocino County" on the label, as specified.

SB-1009 (McGuire) - Alcoholic beverages: wine labels: Mendocino County.

This bill would have required any wine bottled on or after January 1, 2023, and labeled with an AVA that is located entirely within the County of Mendocino to bear the designation "Mendocino County" on the label, as specified.

Status: Never heard in the Senate Governmental Organization Committee

SB-1114 (Allen) - Alcoholic beverages: licenses.

The bill would have allowed an on-sale general licensee to exercise the rights and privileges granted by an off-sale general license, with specified exceptions.

Status: Never heard in the Senate Governmental Organization Committee

SB-1337 (Moorlach) - Distilled spirits: tastings: food preparation: whiskey.

This bill would have permitted tastings by craft distillers to include an alcohol not produced or bottled by the licensee if the alcohol is used as a modifier in a cocktail and purchased from a licensed wholesaler. Additionally, this bill would have allowed distilled spirits to be used in the preparation of food and beverages.

SB-1420 (Allen) - Licensed beer manufacturers: nonlicensee products: storage.

This bill would have permitted a licensed beer manufacturer to have at the licensed premises, or on premises owned by the manufacturer that are contiguous to the licensed premises, as specified, all beers and wines, regardless of source, for storage.

AB-205 (Daly) - Alcoholic beverages: beer.

This bill revised the definition of "beer" for purposes of the ABC Act to provide that beer may be produced using honey, fruit juice, fruit concentrate, herbs, spices, and other food materials, as adjuncts in fermentation.

This bill extended an existing tied-house exception in the ABC Act pertaining to the general prohibition against advertising arrangements between retail, wholesale, and manufacturer to include a performing arts venue (Napa Valley Opera House) and adjacent performance area located in the City of Napa, as specified.

AB-546 (Bigelow) - Alcoholic beverage control: licenses.

This bill would have clarified that a licensee transferring a license to another premise that is either in the process of being constructed, or in the process of construction, must follow the existing 30-day notification requirement.

AB-609 (Levine) - Beer manufacturers: sale of draught beer.

This bill would have exempted a licensed premise operated by a licensed beer manufacturer from a current requirement in the ABC Act that would require on-sale retail licensees that give, sell, or otherwise dispense draught beer to include specified information regarding the beer upon the faucet, spigot, or outlet from which the beer is drawn or in the place of service or consumption, as provided.

AB-840 (Dahle) - Alcoholic beverages: licenses: imports.

This bill authorized the Department of ABC to create and issue a special on-sale general license to a person who owns or operates a facility that is partially located in the County of Placer and partially located in the County of Washoe, State of Nevada (Cal Neva Resort & Casino), as specified.

AB-860 (Berman) - Alcoholic beverages- tied-house restrictions.

This bill would have clarified that a licensed retailer is not obligated to buy or sell the alcoholic beverage products of a distilled spirits wholesaler when selling marketing data to that wholesaler.

Governor's veto message: To the Members of the California State Assembly:

I am returning Assembly Bill 2054 without my signature.

This bill would establish a grant pilot program administered by the Office of Emergency Services (OES) to stimulate and support community involvement in emergency response activities that do not require a law enforcement officer.

Community organizations have a critical role to play in responding to our vulnerable neighbors and community members in crisis.

Many situations involving those who are unhoused, facing mental health challenges, have been exposed to violence, or are experiencing substance use issues may be better addressed with resources and pathways for long-term healing rather than a punitive approach. We must also address the reality that people of color and other marginalized members of our communities are disproportionately harmed by interactions with law enforcement, too often in instances where a badge and a gun are unnecessary.

The underlying goal of this legislation is important and implementing an effective solution will help our communities. Unfortunately, OES is not the appropriate location for the pilot program proposed in this legislation.

My Administration will work with the Legislature and stakeholders during the next legislative session on an implementable solution. Should a grant program be the consensus, such a pilot should be established through the State Budget process.

To that end, I launched the Governor's Council for Post-Secondary Education to encourage collaboration between systems and to make recommendations to the administration in an advisory capacity. The Council is charged with examining issues relating to future capacity, enrollment, planning, community college transfers, and general education and coordination at the state and regional levels.

Additionally, the 2019-2020 budget included funds to begin the work of building a

longitudinal data system to better track student outcomes and increase the alignment of our educational system to the state's workforce needs.

While the intention of this bill is laudable, it is premature to launch a new state body with these aforementioned efforts underway.

AB-1808 (Cervantes) - Public contracts: goods and services: installation of carpet, resilient flooring, and synthetic turf.

This bill would have required the Small Business Advocate, within the Governor's Office of Business and Economic Development, to collaborate with the California Disabled Veteran Business Enterprise Program Advocate regarding the implementation of the DVBE, including, but not limited to, promoting DVBE certification to veteran entrepreneurs and veteran-owned small businesses and undertaking reasonable means to assist state agencies in improving small business and DVBE procurement participation.

AB-1809 (Cervantes) - Disabled veteran business enterprises.

The bill would have established the Procurement Transparency Act of 2019 and would have authorized a state agency to award a contract for services or information technology (IT) that has an estimated value of between \$5,000 and \$500,000 to a certified small business (SB) or to a DVBE as long as the agency obtains price quotations from two or more certified SBs or DVBEs. Additionally, this bill would have made various changes to the California DVBE Program, which are intended to address issues and findings from the 2014 and 2019 state audits of the targeted DVBE procurement participation program.

AB-753 (Eduardo Garcia) - Tribal gaming: compact ratification.

This bill ratifies the tribal-state gaming compact between the State of California and the Cabazon Band of Mission Indians, California, executed on August 21, 2019.
